It is intimated that vide above reference, a representation addressed to Chief Administrator, HSVP, Panchkula has been received. The matter has been examined and it has been decided to allow the provision of a cut out (3'-0''x3'-0'') in the ground floor roof slab on the rear side of single storey booths in all the HSVP Shopping Centres; which can be covered by a steel Shutter/temporary provision and its location shall be at the discretion of the owners. This provision will solve the purpose of maintenance on terrace for water tank/Solar panel etc. which will be approachable through this cut out with the help of steel ladder.
